These sessions aim to foster collaboration and idea generation within each thematic area, providing a tailored and immersive learning experience for participants.

#### CoP on Social Innovation Meeting, Studio 211&212, level +2

#### Opening and Welcome: 14.00-14.15

#### Plenary Session on Social Innovation Priorities in ESF+ Programmes: 14.15-14.45

This session is dedicated to sharing key messages from the report 'Analysis of Social Innovation dedicated Priorities within ESF+ programmes (2021–2027)' and providing a Q&A session. Information, findings, and insights from this report will be discussed in World Café Part I.

#### World Café Part I: 14.45–15.30

Participants will be allocated to discussion tables to engage in brainstorming and exchange ideas regarding the information and findings of the Desk Review. They will explore how these insights can be employed by the CoP on Social Innovation members to enhance the implementation of the ESF+ SI priorities and facilitate the transfer and scaling-up of successful social innovations. The inputs gathered from these exchanges will shape the development of the 2024 work programme.

#### Plenary Session to Validate the Findings: 14.30–15.00

This session is dedicated to validating the findings of the *'Innovative Approaches Promoting Social Inclusion: What Do They Look Like?'* event. It will include a presentation of the findings/results, followed by an interactive discussion to validate the outcomes and potential products.

#### World Café Part I: 15.00-15.30

Participants will be allocated to discussion tables to engage in brainstorming and exchange ideas on how the CoP on Social Inclusion can facilitate addressing social inclusion challenges using ESF+. Groups rotate every 15 minutes to address a variety of topics, including call design, partnership, monitoring, and specific purpose-related challenges within subtopics of homelessness, child poverty, community living, and long-term care. We will discuss the 2024 work programme to stay aligned with social inclusion needs and priorities.

#### CoP on Employment, Education and Skills Meeting, Studio 314&316, level +3

#### Opening and Welcome: 14.00-14.20

This session will briefly review the work of the CoP: What has been achieved since last November and what do we plan for the rest of the year? We will also introduce the members of the CoP's Steering Group and the invited moderators, who will host the six tables of the World Café.

#### World Café Parts I and II: 14.20–15.30

Participants will be divided into six groups to discuss their views and experiences about the cooperation challenges between NGOs and public agencies (PES/municipalities) working with labour market integration and training of vulnerable groups. Each table will work on a different aspect of the topic, such as *How to involve NGOs in reaching out to vulnerable groups? How to finance them and monitor their work? How to decide which groups may benefit most from NGO services?*

Implementation of Accompanying Measures: Common Challenges and Solutions: 14.30–15.00

In this session, participants will collaboratively explore the key challenges and potential solutions for implementing accompanying measures. Participants will write their ideas on sticky notes and then use dot voting to choose the most promising solutions. This visual representation will guide our future discussions and prioritise the most concerning issues.

#### World Café Part I. Best Practices on Implementing Accompanying Measures: 15.00–15.30

During the World Café session, practitioners from different Member States will share their successful practices for implementing accompanying measures. Following brief presentations, participants will engage in open dialogues, ask questions, and share their thoughts and observations. Participants change tables after 15 minutes.
